CITY WATER SHUT OFF

Many Adair residents have asked questions about the water shut off that happened last month. Here is the story. On Tuesday, April 9th, a company was doing some directional drilling near Santiam Christian School and hit a main water line in the process. The break caused water to shoot up about 60 feet in the air and had to be shut off quickly to reduce loss and to begin to repair the line. The shut off affected about 3/4 of the City.

City staff immediately set out to inform residents of the shut off through social media, our website, and the message on our phone system. Then, the City prepared and hand-delivered a notification to every resident to boil water which is a requirement from the Oregon Health Authority. The notice was a precaution and was not intended to alarm residents about the safety of the water. The repair work was handled very quickly and the water was back on by early evening the same day. The water was tested on Wednesday morning and cleared 24 hours later on Thursday, April 11th as safe. The residents were then informed that the boil water notice was lifted.

MUNICIPAL COURT CHANGE
