THE ADAIR CERT TEAM RECRUITING VOLUNTEERS

The Adair Village CERT team is actively preparing to meets the needs of the community after a disaster. We have come a long way from having no trained volunteers to our current group of nine committed people in continuing training (including our trainers). And, we have gone from having no materials or equipment for training or use in a real disaster to having a good supply of both. What we need is to grow so that when the time comes, there are enough people to form small teams to assess damage, do search and rescue, triage, traffic control, and assist Adair Rural Fire & Rescue (ARF&R) and other responding agencies as requested. Our team is likely to be early on the scene as well as the last group helping with recovery. The bottom line is that we have cared enough to start CERT and we care enough to try to grow it so that we can be as successful and ready as possible. STORMWATER EDUCATION

Spring is almost here and some of you may be starting your annual spring cleaning. Help keep our environment healthy with a few simple steps:

- Sweep up any loose debris rather than washing it into the street.
- Find hazardous wastes like paints, oils, vehicle fluids, or pesticides? Please do not flush them or pour them down the drain! Instead, check for one of Republic Service's Residential Household Hazardous Waste Events.
- Do you have loose materials like dirt or mulch stored outside? Secure a tarp over top of it to prevent the material from being washed away before it can get placed in your gardens.
